Failure to appear at the agreed meeting will result in exclusion from the DANISH Transport Standard.

If the assembly centre fails to comply with its obligations in any other way, c.f. the DANISH Transport Standard, for example, but not limited to , failure to respond to inquiries and/or meeting deadlines, DANISH Transport Standard approval may be revoked.

After withdrawal of DANISH Transport Standard certification, a fee of DKK 20,000 is charged if recertification is requested.

3.2.12: e) equipment for online surveillance of all tracks at the cleaning station. The equipment must be IP-cameras, that are connected to a network. Further more, the cameras must be up to date in regards to optics and the quality of the images. The cameras should be able to transfer images with a SFTP-protocol.

It must be clearly indicated which track is being filmed, the vehicle's registration number must be clearly visible and the time of recording must be visible on every individual image, c.f. agreement entered into through the Declaration of Accession from the DANISH Transport Standard certified cleaning and disinfecting stations.

4.3: An unannounced inspection of the soap washing station, will be carried out.

4.4: A DANISH Transport Standard approval may be revoked without notice based on the following points:

Correction

One violation: A dialogue meeting with a SEGES representative. More than three violations within one year: A summons to appear at a dialogue meeting before the Steering Committee for the DANISH Transport Standard to provide an explanation. The Steering Committee has the following options:

- acceptance of the explanation
- rejection of the explanation

After rejection or failure to appear at a confirmed meeting the Steering Committee has the following options:

- Drawing up of a plan of action. This must contain a report on how violations can be avoided in the future.
- The DANISH Transport Standard certificate is temporarily withdrawn. If the haulier or exporter fails to comply with his obligations in any other way, c.f. the DANISH Transport Standard, for example, but not limited to, failure to respond to inquiries and/or meeting deadlines, the DANISH Transport Standard approval may be withdrawn for a period of 12 months. After withdrawal of DANISH Transport Standard approval, a fee of DKK 10,000 is charged if recertification is requested.

If a haulier or exporter has been excluded and wants to re-register via the same or another company controlled either directly or indirectly by him/her within 3 years after the exclu-



- › sion, the possibility of re-registration will, however, be assessed specifically based on the seriousness and intent of violation that led to the exclusion.

1.3.2: the vehicle has been cleaned according to official regulations on arrival at a DANISH-certified cleaning and disinfection station.

It follows from Regulation 2020/688, Part II, Section 1: Article 4 b, that means of transport used for the transport of farmed animals shall be cleaned and disinfected as soon as possible after every transport of animals, hatching eggs or any item representing an animal health risk, and, if necessary, cleaned and disinfected again and in any case dried or allowed to dry before any new loading of animals or hatching eggs.

Vehicles that have not been cleaned according to the authorities' regulations upon arrival at a DANISH-certified cleaning and disinfecting station will be rejected and returned for rewashing. In case a vehicle is rejected more than twice within a period of 2 weeks, the third rejection will trigger an inspection fee of 100€. The fee will be charged by SEGES. If payment fails, a washing certificate cannot be issued.

1.3.2: According to Article 12, Section 1, sub-section (a), ii) in the Council Directive 64/432/EEC concerning animal health problems affecting intra-community trade in bovine animals



- › and swine (Trade Directive), transport for cloven-footed animals must be cleaned and disinfected immediately after every transport of animals. The requirement applies throughout the EU. In addition, there is a national requirement, c.f. Executive Order on the cleaning and disinfection of transport for cloven-footed animals.

1.3.2: In case a vehicle is rejected more than once within a period of 2 weeks, the second rejection will trigger an inspection fee of 100€. The fee will be charged by SEGES. If payment fails, a washing certificate cannot be issued.

1.3.5 b: The soap wash must be notified to the cleaning and disinfecting station no later than 24 hours prior to arrival.

- Obligatory cleaning and disinfection: In addition, hereto, the vehicle's cargo area is opened, and it is inspected, if the loading equipment as well as rubber boots and sacks that contain shavings are clean. Due to certain provisions, interior disinfection is not applicable for closed SPF-approved vehicles.
- Safety wash: For closed SPF-approved vehicles it applies that a safety wash is achieved by a preceding interior disinfection followed by an obligatory cleaning and disinfection and finally another interior disinfection. In this case, the vehicle is not opened by the personnel of the cleaning station.

Thereafter, disinfected boots must, along with an unused disposable overall, be placed in a plastic bag and closed with strips. change to 3.2.5 that the driver's and any assistant's boots are cleaned in water with soap and disinfected by the staff of the cleaning and disinfection station. Thereafter, disinfected boots must, along with an unused disposable overall, be placed in a plastic bag and closed with strips.

4.2.1 physical separation between each vehicle, which effectively prevents splashing from other vehicles, if soap cleaning of several vehicles is performed simultaneously. At the established cleaning and disinfecting stations, the soap cleaning may only be performed in a designated and secluded lane. Changed to 4.2.1 that there is a specially designated and secluded track to perform soap cleaning (this seclusion might be a strong plastic or rubber tarpaulin from floor to ceiling)



- › 4.2.4 following part shall be erased: During winter, the tank containing the disinfectant must maintain a temperature of 20-30°C. The temperature of the liquid must be measured twice a day and the temperature must be registered on an inspection sheet.
